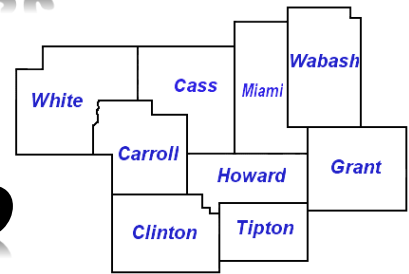

## Mail-O-Graphic Tournament

January 2020

### Official Rules

1. The tournament will be open to all Adult bowlers with a USBC membership card who bowl in certified competition and have bowled at least 21 games in their respective leagues before the qualifying dates. This is a USBC Certified Tournament.
2. Entry fee is \$10.00 per person, per league. Prize fund will be returned 100% on a ratio of 1 in 8 entries. Entry fee breakdown is—\$6.00 Prize Fund, \$1.00 to tournament expense, and \$3.00 District 6 Ways & Means.
3. Handicap shall be based on 90% of 220, based on member's current average of 21 games or more at the time of participation. All others will bowl scratch. Players may submit entries for each league in which they bowl, but may cash only once. Current average in respective league shall be used. There will be a Men's Division and a Women's Division with separate prize lists. If less than ten (10) in a division, there will be only one division.
4. The tournament dates will be Sunday, January 12 through Saturday, January 18, 2020. Only scores bowled in certified competition will be used. If the player is absent the week of tournament, he/she may use the scores from the following week (January 19 through January 25, 2020). If the player is unable to bowl either week, the entry fee will be forfeited (no refunds).
5. The entry form and subsequent score sheet must be completely filled out or the player may be disqualified without refund of entry. **Bowler's USBC ID number must accompany the entry.**
6. Entry deadline is January 6, 2020, with entries postmarked no later than midnight January 6, 2020. You may submit applications by e-mail, but check must be received before entry is official. *Confirmations will be sent via e-mail only.*
7. Scores bowled must be verified by your league secretary or you may send your league recap sheet with the verification form. Verification forms and recap sheets are accepted by email. Scores must be returned by February 2, 2020, or they will be disqualified.
8. A separate entry form must be submitted for each entry and/or league in which you will be bowling. Full fees must accompany entry.
