His career high game is 290 and career high series is 759 with many series of 700.

Dave was inducted into the Columbus USBC Hall of Fame in 2007. He was one of the first male inductees USBC Hall of Fame.

Received Friend of Indiana State USBC WBA award presented by President Judy Smith in 2011.

Dave won several Indiana State Bowling Association awards, which include District Director of the Year Award in 1997 and 2004, and a District 9 Service Award.

He has also won many local awards including two sportsmanship awards, several high game and high series awards, and several league championships.

Dave is an active community member and continues to support Walking for the Cure for breast cancer. Additionally, he is an American Legion Member and has been for over 28 years.

Dave is an active member of the Bartholomew County Veterans Honor Color Guard, supporting local veteran funerals and events.

He volunteered his time at a local school as a mentor for children and helped involve several of them in bowling with field trips to the bowling center. He also conducted a class on bowling etiquette for the school's Physical Education Class.

Little did Dave know that when he became involved in bowling during his junior year in high school in 1965, that bowling would become a life-long passion, which would benefit from his dedication and commitment as a bowling volunteer.

If not for his health issues, Dave would still be an outstanding ambassador to the sport he loved—bowling!
