# 2024 District 6 Open Invitational

- This is a one-day Singles and Virtual-Doubles Scratch Tournament that is open to District 6 USBC Certified Bowlers only. You must enter Singles Event to qualify for the optional Doubles Event. Youth bowlers are not eligible to compete in this tournament.
- Tournament date is Sunday, November 24, 2024. Squad Times are 9:30 am and 12:30 pm. There shall be a maximum of 90 bowlers per squad three (3) bowlers per pair with a maximum of four (4) bowlers a pair. Entry deadline is November 17.
- Participant must be a league bowler in City of Firsts USBC, Grant County USBC, Loganland USBC, Tipton USBC, and/or White County USBC.
- 4. Male participants must wear a collared shirt or any bowling related jersey (crewneck, polo, sash zip, mock) and slacks or dress shorts. Ladies attire is slacks, capris, shorts, skirts or skorts may be worn, provided the length is below the competitor's fingertips when standing with her arms down at her side. Tank tops are prohibited for all.
- 5. There will be 10 minutes of practice.
- 6. The Tournament will be Singles Event of three (3) games; re-entries <u>ARE</u> allowed for the qualifying squads. Both squads will be merged with a 1:6 ratio being used to identify qualifiers for the 2-game advancers' round. Qualifying scores will be dropped and advancers will bowl two (2) more games to determine the finalists for the stepladder finals with a one game-match for each match until a champion is determined.

- 7. The Optional Virtual Doubles Event will be any combination of two qualifying Singles Event scores combined for the Doubles score. Doubles partners may bowl on different squads, but entries must be received before either participant bowls in the tournament. You may enter Doubles Event with different partners up to a maximum of four times.
- Singles Entry fee and Singles Re-Entry fee are \$40.00 per bowler. Doubles Entry fee is \$15.00 per bowler per entry. Submit Doubles entries together on one entry only.
- There will be a Singles Prize List and a Doubles Prize List based on the entries of each event. Prize ratio will be at least 1 for every 6 entries in each event.
- 10. Highest series of each Singles Squad (9:30 am and 12:30 pm) shall receive a complimentary entry into the next *Indiana Scratch Classic* held at Mike Aulby's Arrowhead Bowl, Lafayette, Indiana, or tournament hosting center. (A \$100 value—no cash value, and is non-transferrable.) Entrants can win only one entry.
- Late entries will be accepted 7 days before bowling date, based on lane availability. A late fee of \$5.00 per Singles Event and \$10.00 per Doubles Entry will be assessed.
- Walk-ins will be accepted based on lane availability and must arrive one hour prior to squad time—cash only will be accepted.
- Sport Pattern will be used and lanes shall be oiled between each squad

This tournament shall be rotated between each center in District 6, giving each District 6 center the opportunity to host. Loganland USBC (2023-24); City of Firsts USBC (2024-25); Grant County USBC (2025-26); Tipton USBC (2026-27); White County USBC (2027-28)
