**TOURNAMENT RULES**  
**2025 INDIANA STATE JAMBOREE**  
**SCOTCH DOUBLES DRAW TOURNAMENT RULES**



1. This tournament is open to any certified Indiana State USBC. Upon request, bowlers must display a current valid USBC sanction card or a league receipt for the current year signed by the League Secretary.
2. This is a "Scotch Doubles Draw Tournament" that is being run as part of the activities for the 2025 Indiana State Jamboree. All bowlers will submit individual entries for the tournament, and the tournament officials will randomly make up the Scotch Doubles partners for each team that will compete in the tournament.
  - The Scotch Doubles will alternate throws with their blind-draw partner. Bowlers will compete in one three (3) game series. Standings will be based on the total of actual pin fall of each Scotch Doubles team.
  - Tournament will pay at least 1:5 places.
  - The top 4 will have a Scotch Doubles Format 2-game series "roll-off" round elimination—
    - 1<sup>st</sup> and 4<sup>th</sup> places will bowl each other at the same time as 2<sup>nd</sup> and 3<sup>rd</sup> places compete.
  - After the 2-game roll-offs, the winners of the two roll-offs will bowl each other in a one game roll-off Scotch Doubles Format for the Championship.
  - Tournament high game and high series will receive prizes.
3. AVERAGES: Averages for determining team pairings shall be: Use highest USBC sanctioned league average based on a minimum of 21 games for the 2024-2025 season. Bowlers without a 2024-2025 Book Average will use the current highest average of 21 games or more as of October 4, 2025. It shall be each bowler's responsibility to verify the accuracy of their average. The bowler is responsible for providing verification of the average to be used to the tournament manager.
4. The cost of participation for this tournament is \$25.00 per bowler. This fee is comprised of \$15.00 prize fund and remaining for expenses. The prize fees will be returned 100% in cash prizes to the bowlers and shall include a prize for high game and high series. The prize ratio will be at least one paid position for every five paid entries. Entries postmarked after October 4 will have an additional late fee of \$10.
5. All bowlers must check in at the tournament desk. The tournament officials on a random basis will assign team members and lanes; no switching of partners will be permitted.
6. Bowling shall begin in accordance with a previously arranged schedule. **(Any player or team arriving late shall begin play and the score shall count beginning with the frame then being bowled and receive a zero score for all previous frames.)**
7. Ten minutes of practice will be provided before the start of the Tournament Squad.
8. Walk in entries (\$25 + \$10 walk-in **cash only fee**) will be allowed based upon lane availability. Mailed entries shall be received by October 4, 2025.
