RULES FOR INDIANA STATE 500 CLUB TRIO TOURNAMENT

1. This is a three-member team event tournament. At least one member of each team must be a member of the Indiana State 500 Club. Other team members may be 500 Club members, 600 Club members or non-club members, etc. ALL three must be members of USBC must bowl in an Indiana certified league or reside in Indiana with a street address (no PO Box).
2. Multiple participation will be allowed, but one player of the three must be different.
3. Current (2025-2026) USBC card (or receipt) must be presented by each bowler at time of check in.
Teams should check in at least 30 minutes before their scheduled squad times.
4. Entrants will use their highest 2024-2025 USBC sanctioned league average for 21 games or more. If no 2024-2025 winter league average, highest 2024 summer league average for 21 games or more may be used. If entrant has no prior winter season or summer league average she may use her highest current average for 12 games or more as of the date of bowling. If none of these, bowler must bowl scratch.
5. Handicap will be 100% of the difference between the entering average and 200.
6. USBC Rule 319(a)3 concerning the accuracy of averages will be in effect for this tournament. USBC Rules 319(a)2 (the ten pin rule), 319d and 319e will not be in effect.
7. Teams will bowl three games on one pair of lanes.
8. Entry fee of \$90.00 per team, \$30.00 per person. Prize list will pay at least one place for every ten entries. Prize fee will be returned 100%. Make checks payable to "Indiana State 500 Club." Closing date for entries is midnight October 1, 2025.
9. Additional squads will be added during the course of the tournament if necessary; however, no squad will be added after the final squad on October 5 at 1:00 pm.
10. In case of a tie for first place, co-champions will be declared.
11. Claims for errors in scoring and protests must be filed with a tournament official before leaving the bowling center.
12. Substitutes will be allowed provided they meet the tournament rules for entrants including the requirement that one team member must be an Indiana State 500 Club member.
13. This tournament is USBC sanctioned and USBC rules will apply. The tournament manager shall have the authority to rule on any and all disputes or protests.
14. Application for Indiana State 500 Club membership may be submitted with tournament entry.
